**Cloverleaf S.O.A. Rolling Equipment Insurance**

Rolling Equipment (sulkies & jog carts) shall be insured at Cloverleaf S.O.A. contractual tracks during:

- The time a horse is on the track after being called to post until the horse leaves the track after the race. This applies for qualifying, non-betting purse, pari-mutuel races, and official schoolers on qualifying day while starting gate is in use with an official present.
- The time a horse is on the track warming up for a pari-mutuel and/or a stake race only.
- Cloverleaf S.O.A. will pay all claims in excess of \$25, to a maximum of \$2,400 for ALL damages or \$200 per wheel.
