## **Please Read Racing Application Conditions Carefully**

In consideration of the privileges of ship-in space being allotted, and entry in any races, in respect of all of the aforementioned horses by the company known as Prince George's Racing Ventures, LLC (herein "Rosecroft"), the applicant, who may be the trainer and/or owner of the above named horses or his/her agent and all persons for who he is acting, upon execution of this application agree, accept, and are bound by all the terms and conditions set forth.

### **Conditions**

1. Rosecroft reserves the right, without any reason existing or being given, at any time: A) To refuse ship-in space to an Applicant; B) To revoke and terminate without notice at any time, the Applicant's privilege of ship-in space at Rosecroft; C) To refuse permission to Applicant to enter and to race horses at Rosecroft; D.) To refuse at any time the Applicant and/or his employees or persons under his charge or control or any of them admission to the Rosecroft backstretch, barn area, racing paddock or any other grounds of Rosecroft;
2. The Applicant agrees that prior to entering horse(s) for races at Rosecroft he/she will furnish a current negative Coggins Test and other documentation may be requested by Rosecroft from time to time to ensure the safety of all participants.
3. All horses must have a valid electronic eligibility certificate through the USTA before entering to race or qualify.
4. The Applicant agrees to enter the horses in his/her care as agent or owner in the conditions that have been written in their said class by the Racing Secretary.
5. Any pass issued at Rosecroft to Applicant, or any person employed by Applicant or under his charge or control, shall, upon termination of such relationship, deliver said pass to the Security or Judges Office at Rosecroft for cancellation. Passes are issued for the personal use of the pass holders and are not transferable. Any passes transferred to another person will result in the removal of all parties involved from the grounds.
6. Rosecroft will provide ship in stalls to those participating in that day's races. Any damage caused to such accommodations by Applicant will require Applicant to reimburse Rosecroft for any such costs prior to entering any horses at Rosecroft in the future.
7. The Applicant agrees to be governed by and to obey the rules of racing of the Maryland Racing Commission, the U.S. Trotting Association and when on Rosecroft premises, the rules and regulations of Rosecroft. The applicant is subject at all times to the Prince George's Racing Ventures, LLC Racing Guide and any local guide and regulations as promulgated by Rosecroft and updated from time to time. It is the responsibility of the Applicant to make his/herself familiar with the Racing Guide and all of its applicable provisions.
8. If Applicant, or any person employed by the Applicant, plans to exercise, train or race a horse on the racetrack he/she must sign the "**Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement**" as set forth by Rosecroft. Such form must be filed with the Racing Office prior to any exercise, training or racing of horses on the Rosecroft track.
9. All Applicants must make arrangements with the racing office prior to shipping in to the barn area. All individuals and horses entering the grounds of Rosecroft must be signed in.
10. Private veterinarians, other than the designated Lasix veterinarian, are not permitted on the grounds of Rosecroft unless approved in advance by the Racing Secretary. ALL Lasix administration for pari-mutuel races and other race as designated by the Racing Office or Racing Commission must be done on-site and by Rosecroft designated Lasix Veterinarian. **NO EXCEPTIONS. Qualifiers do not require on-site Lasix administration.**
11. Individuals aged 18 or older, licensed by the Maryland Racing Commission and with an interest in a horse competing on that race date, may enter the backstretch, ship-in and Paddock areas of Rosecroft. Maryland Racing Commission licenses must be visible at all times. Guests age 13 and older may be permitted in the paddock with a pass issued at the discretion of the Racing Secretary. Minors must be accompanied by an adult at all times.
12. Applicant signing this agreement must show proof of Workman's Compensation insurance as required by the Maryland Racing Commission.
13. Applicant, and all participants earning purse checks or distributions through the Horsemen's Bookkeeper, acknowledges that all payments will be made through Direct Deposit to individual's bank account and proper paperwork must be submitted to Rosecroft by all racing participants prior to any disbursements. All disbursed funds subject to judge's hold or redistribution must be returned by the recipient when requested by the Horsemen's Bookkeeper. Until such funds are returned the recipients' accounts will be placed on hold.
14. Should Applicant provide false or misleading information on this application, or fail to cooperate with Rosecroft with disclosure of any requested information, then Applicant may be subject to revocation of all racing privileges.
15. ***Should Applicant incur a Class 1 or Class 2 Medication violation, racing privileges will be revoked during the stay, appeal period and any extension of the appeal process while awaiting final MRC adjudication.***
16. By signing this agreement Applicant hereby gives permission to Rosecroft, or its authorized agents, access to any and all premises and individuals identified by Applicant on this form and utilized by the applicant. Failure to provide such access shall result in revocation of racing privileges to Applicant, and at discretion of Rosecroft, to any other parties associated with Applicant.
17. A starting fee of \$50 per horse will be imposed for each horse that races. The \$50 starting fee will be deducted from payments otherwise payable to the owner of such horse to CSOA. A 5% Racing Facility Operating Fee will be assessed to the Purse Dedication Funds allocated to each race conducted at Rosecroft.
